A RESOLUTION OF THE TOWN OF FORT MYERS BEACH, FLORIDA, REQUESTING THE COUNTY COMMISSION OF LEE COUNTY TO ADOPT A RESOLUTION APPOINTING THE ROTATING MUNICIPAL MEMBER TO THE TOURIST DEVELOPMENT COUNCIL AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town of Fort Myers Beach shares with the cities of Fort Myers and Sanibel one of the positions on the Tourist Development Council; and

WHEREAS, representation every eight years is not meaningful and effective in a county with the dynamics of Lee County; and

WHEREAS, it is proper for the Town Council to request relief from strict enforcement of Florida Statute 125.0104

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF FORT MYERS BEACH, FLORIDA:

Section 1. Town Request. The Town Council of the Town of Fort Myers Beach hereby requests the Lee County Commission adopt the attached resolution to provide the municipalities eligible for the rotating position on the Tourist Development Council with adequate representation.

Section 2. Effective Date. This resolution shall take effect immediately upon its adoption by the Fort Myers Beach Town Council

RESOLUTION NUMBER 97-

A RESOLUTION OF BOARD OF COUNTY COMMISSIONERS OF LEE COUNTY, FLORIDA, APPOINTING THE ROTATING MUNICIPAL MEMBER TO THE TOURIST DEVELOPMENT COUNCIL , PROVIDING PARTICIPATION; INTENT AND AN EFFECTIVE DATE.

WHEREAS, Florida Statute 125.0104, know as “Local Option Tourist Development Act,” authorizes and directs this Board to appoint nine members to the Tourist Development Council; and,

WHEREAS, one of those members is to be chosen from one of the elected municipal officials of the City of Sanibel, the City of Fort Myers or the Town of Fort Myers Beach on a four year rotating basis; and,

WHEREAS, adequate representation by the lower population municipalities is important as is continuity in that representation.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF LEE COUNTY, FLORIDA:

Section 1. Appointment. _____, of the City of Fort Myers, is appointed as first alternate member to the Tourist Development Council; _____, of the City of Sanibel, is appointed second alternate and _____, of the Town of Fort Myers Beach, is appointed as third alternate.

Section 2. Participation. All alternates may participate in the discussion of every issue before the Tourist Development Council; however only the first alternate may vote, unless absent then the second unless absent then the third alternate.

Section 3. Intent. It is the intent of the board, upon the completion of the term of the first alternate, to appoint the first alternate as second alternate and the third alternate as first.

Section 2. Effective Date. This resolution shall take effect immediately upon its adoption.
